Dear Stakeholders,

This is to inform that the above Management Unit under the Parent Company **IOI Corporation Berhad** with RSPO membership number **2-0002-04-000-00** had appointed Intertek Certification International Sdn Bhd to conduct the ~~Initial Certification/Recertification Audit~~ / **Surveillance Audit (ASA-02)** at **Morisem POM** and its supply base, located at **Lahad Datu, Sabah**. The audit will be conducted from **13 – 17 October 2025** against the requirements of:

- Malaysia National Interpretation (MYNI) 2019
- RSPO Principles & Criteria 2018

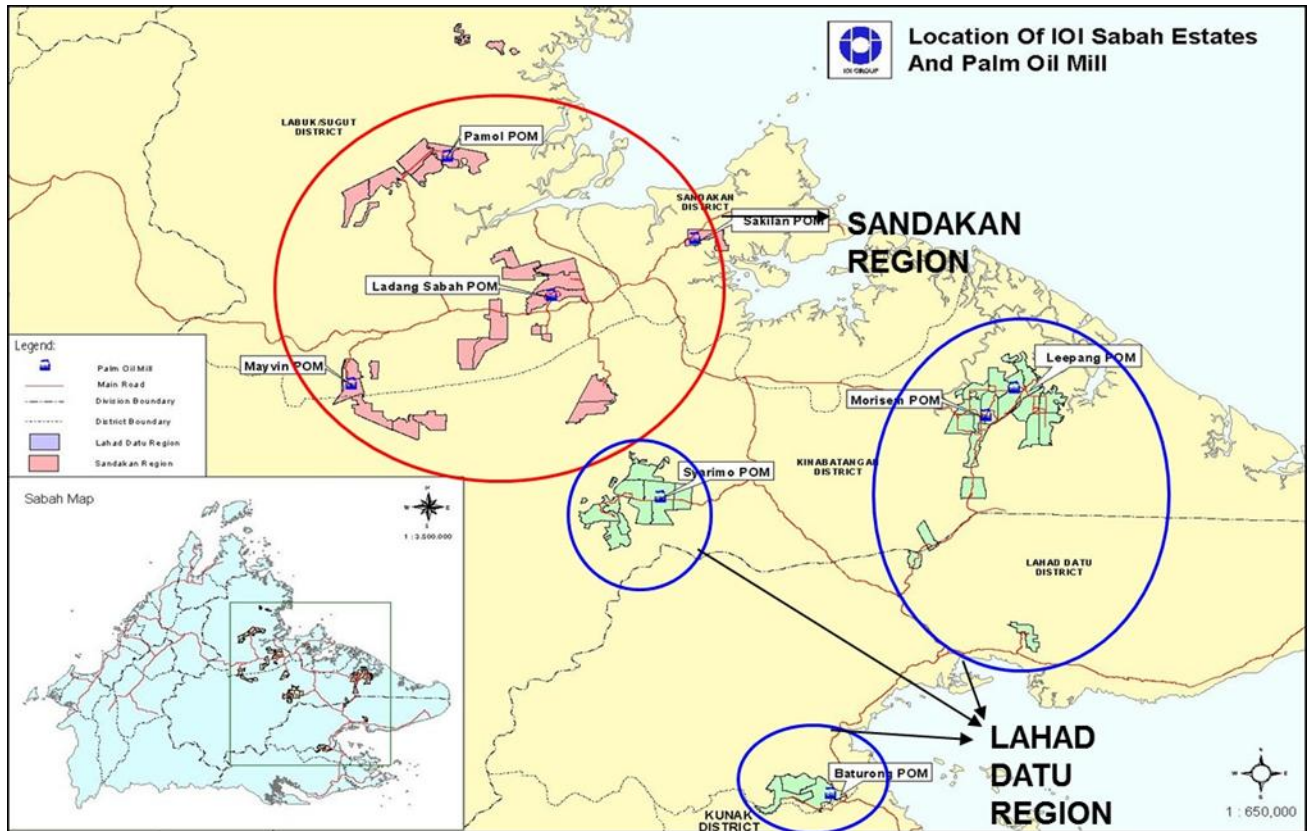
